SUMO SUIT HIRE AGREEMENT & DISCLAIMER

(Please read carefully before signing the Agreement)

The object of Fun Sumo Wrestling is to trip, throw, pull or force your opponent over the edge of the safety mat, or force them onto their back. The winner under usual Sumo etiquette is allowed to "bodyslam" (Bellyflop) his fallen opponent.

When used correctly the equipment can be hilarious fun, but if used incorrectly, it may represent a serious injury to anybody using it. The Sumo Wrestling Mats should have plenty of clear space all around them - 2.5m, preferably a lot more. Spectators should be kept a similar distance away, when wrestlers fall, they fall easily and roll off the mat. Paul's Party Events will not take responsibility for accidents happening as a result of there not being enough room around the mat.

Safety of participants is paramount. In order for you to get the most fun and enjoyment from the Sumo Suits, please observe these instructions. If there is any doubt, or you have questions, please do not wait to ask.

Ensure all protection supplied is being worn before games start. Neck braces and helmets resembling traditional Sumo hairstyle are compulsory. The Sumo equipment supplied is solely for the purpose of Fun Sumo Wrestling. Paul's Party Events will not take responsibility as a result of unsupervised use of the Sumo equipment.

Ensure that the helmet is securely fitted to the head, not too tight as to choke, but it should not be loose or able to move around freely, it should be secure.

Ensure the neck brace is secure but not overly tight or loose.

The Sumo suit is a one size fits all, this is to be worn at all times.

The wrestling event should be supervised by 2 responsible adults at all times.

If anybody refuses to wear the required safety equipment, then they DO NOT wrestle. You are fully responsible as the hirer for both the equipment and participants. If unsupervised, then nobody wrestles until it is supervised again!

Ensure there is adequate First Aid equipment at hand before using the equipment.

Sumo suits, mats, helmets and neck braces must be returned in an acceptable condition, ie. clean, unspoiled and undamaged.

No eating, drinking, shoes, glasses, jewellery, buckles, key rings, studded clothing, pets, silly string, toys or other sharp instruments and items which could cause injury or damage allowed on the sumo equipment at any time.

Remember, these are hired for fun!! Do not be overly aggressive or hitting your opponent excessively hard!! The idea of the game is to force your opponent over the edge of the mats or onto their back, not beat them and crush them as hard as you can!!

Paul's Party Events will not be held liable in any way for any injury or damages to those using the Sumo Wrestling Suits or which may result in injury and any other loss or damages to any onlookers beyond my control.

I personally accept all responsibility in connection with the Sumo Wrestling Equipment, for any harm, injury, loss or damage including all associated risk which may occur while I am hosting, controlling and or participating in this event.

It is my intention with this signature to exempt Paul's Party Events from all liability whatsoever for personal injury, property damage or death caused whilst using this equipment. I verify that I understand the nature of the activities involved. I will endeavour to ensure that all people using this equipment are physically fit, and able to participate in the event.

I further state that I am over the age of 18 and legally competent to understand and sign the agreement.

PAYMENT

After confirmation of the fee for the duration of your event, payment is requested in cash prior to the event.

A fixed deposit of €750 is additional for single day hire of one set of Sumo equipment. (2 x Sumo suits, 2 x helmets, 2 x neck braces and Mats).

Payment of the deposit and fee are to be made together, with the deposit being refunded after the Sumo equipment has been inspected at the end of your event. For larger events, the price of the deposit will be calculated according to the needs of your event, and refundable after inspection of the Sumo equipment again at the end of your event.

A Cancellation Charge of 60% of the agreed fee is applicable if your Event is cancelled earlier than 7 days prior to the set date, regardless of reason. Events cancelled within 2 days of the set date are subject to a Cancellation Charge covering 80% of the agreed fee.
